## Business Development & Marketing

The BDBMC attends regional and national meetings with key industry sectors to develop relationships with industry leaders and recruit a pipeline of potential prospects and leads for Martin County. In FY 2019, the team attended the 2018 NBAA Business Aviation Convention & Exhibition (NBAA-BACE) in Orlando, FL.





The BDBMC team also attended the Florida CDFA -DEO Opportunity Zone (OZ) Conference in Orlando and produced a local OZ Session to help promote Martin County's two Opportunity Zones for investment featuring RIO and the Village of Indiantown.



## Small Business Assistance



Since 2015, the BDBMC has collaborated with **Indian River State College** and the **Small Business Development Center** to provide quality training to local small business owners and entrepreneurs in order to help them start-up and grow their businesses.

Funded in part by the Martin County Board of County Commissioners, the City of Stuart and other partners, the Business Accelerator Program provides small business counseling, technical assistance and training and opportunities to pitch for and win small business grants.

In FY 2019, 44 local business owners and entrepreneurs in three different cohorts throughout the County - one situated in the Village of Indiantown - participated in the BAP. The BDBMC awarded \$17,000 in small business grants to help provide new equipment, professional training and/or other operational investments to the winning pitch event recipients.

In FY 2019, the BDBMC planned the School District's Professional Development Day Business Tours for Guidance Counselors and the 2019 Martin County Career Fair, in conjunction with IRSC, United Way of Martin County, Palm City Action Team, Senior Corps and the Vietnam Veterans of America. Also, the BDBMC team supported and assisted the region's new State of the Jobs Conference for High School Students with its partners in St. Lucie and Indian River counties.

## Industry Retention & Development

The BDBMC is proud of its association with local chapters of regional industry groups that seek to grow their industry through workforce development, job training, business development and advocacy.

During FY 2019, the BDBMC team supported a variety of activities with key partners and hosted two manufacturing roundtables.

Additionally, the BDBMC was a sponsor of the 2019 Treasure Coast Skills Gap Study 2.0 by Patricia K. Gehant, Gehant & Associates conducted by the Economic Development Council of St. Lucie County - through its highly collaborative and regional Workforce Readiness Task Force - and CareerSource Research Coast.
