SUPPLEMENTAL MEMORANDUM

SUMMARY: This item is to discuss staffing arrangements in light of the pending vacancy of the Business Development Executive. Staff has developed arrangements with Business Flare, a firm specializing in economic development and with local knowledge.

RECOMMENDATION. Motion to approve the proposed scope of service for Business Flare and authorize Interim Executive Director to finalize arrangements.

Discussion

Pierre Taschereau has accepted a position elsewhere. Consensus opinion is to keep the position open in order for the new Executive Director to hire the individual.

Interim Executive Director met with Business Flare founder Kevin Crowder on Friday May 17, 2024 following the Executive Committee meeting. The firm specializes in economic development practice. Business Flare is headquartered in North Miami, with an office in Stuart and other locations around the state.

Business Flare has very deep local knowledgeable, having done work for both the City of Stuart and Martin County. Kevin Crowder led the team effort producing the Innovation Hub plans (the commercial area between Dixie and US1 in south Stuart) and in currently engaged in updating the economic development toolkit for Martin County.

Business Flare proposes to perform the Business Attraction and Expansion Services for a flat fee of \$10,000 per month with no limit on hours (PLEASE SEE attached Scope of Services along with a summary of the firm). Funding is available from attrition due to the vacancies.

Scope of Work

- 1. Business Attraction and Expansion Project manage the BDB's business expansion and attraction projects, including assistance with site identification, incentive and tool kit applications, meeting coordination, and all other tasks necessary to complete the pending projects, and new attraction and expansion projects that are submitted to the BDB.
- 2. Provide all support services necessary to effectuate Task #1, including administrative, real estate, market research, preliminary site fitment, economic and financial feasibility assessments, and impact analysis.
- 3. Coordinate with Martin County and other agencies as needed to facilitate and assist the projects.
- 4. Develop and deploy the Martin County Street Economics dashboard, consolidating real estate, economy, workforce and labor, demographic, and foot traffic information into one platform with ongoing insights and at least quarterly updates, for use in business attraction, retention and other BDB initiatives. This task also includes customized data discovery sessions with prospects.

Fee: \$10,000 per month

Term: 6 months, can be renewed at the BDB's sole option on a month-by-month or other term as desired by the BDB.

Additional Services, at the BDB's direction and request

- 1. Participate in Pulse Visits or other meetings as directed.
- 2. Coordinate the periodic manufacturers' roundtable.
- 3. Begin branding framework for Innovation Hub.

Fee: \$345 per hour and/or a flat fee for some services can also be provided.

Term: To be defined by the Client.
