# **About the Martin County Industrial Development Authority**

When high interest rates and volatile economic conditions threaten to leave a viable project stalled on the sidelines, the MCIDA can move a project from the starting line to the finish line. Empowered to offer low-interest, tax-exempt loans to qualified projects, this specialized funding option is available exclusively through the BDB and the attendant MCIDA board.

Created in 1981, MCIDA assists in financing and refinancing projects by issuing tax-exempt bonds for qualified private projects with public uses and benefits. Examples include social service centers, retirement housing (if registered as 501(c)3), educational, manufacturing, tourism, water and sewer, and solid-waste disposal facilities.

Revenues derived from the projects go toward paying the principal and interest on the bonds, shielding the county from liability for any debt incurred.
