1. Call to Order, Pledge of Allegiance and Roll Call: Susan Rabinowitz called the meeting to order at 8:38 AM. A quorum was established by roll call.

#### 2. Comments

- I. Investor Presentation: Inez van Ravenzwaaij thanked Richard Kolleda from Spherion Staffing & Recruiting and Bill West from Acquisition Experts for their new investments. Inez van Ravenzwaaij also thanked Brian Powers, Chairman of the Martin County Industrial Development Authority for their renewed investment.
- III. **Executive Director Report**: William Corbin went over the Executive Director Report.
  - Legislative Update
    - FEDC the Florida Economic Development Council sent an email to its members after the legislative session finally concluded last week, the evening of Monday, June 16. The email detailed several economic development-related pieces of legislation that were passed along with the state budget. Here are the highlights:



- SelectFlorida received \$900,000 in non-recurring funds to expand the department's trade show and mission grant program to small manufacturers, with the goal of enhancing their competitive edge in international trade markets.
- HB 7031 eliminates the 2% tax on commercial leases. Florida was the only state that levied that type of tax, putting Florida businesses at a competitive disadvantage, compared to businesses in other states. Per the Florida Chamber of Commerce, the removal of Business Rent Tax will save Florida businesses a total of \$900 million. HB 7031 also includes the extension of the data center tax exemption through June 30, 2037. This exemption is important because it incentivizes investment in the data center sector, which is experiencing explosive growth nationwide, and illustrates the opportunity for communities like Martin County to take advantage of and capture some of the benefits of this investment growth.
- SB 1516 creates the International Aerospace Innovation
   Fund, which will be administered by Space Florida. This fund is
   intended to drive global aerospace research,
   commercialization, and workforce development in the state.
   The goal of the fund is to foster strategic partnerships between
   Florida-based aerospace companies, international
   businesses, research institutions, and space agencies,
   positioning Florida to attract new projects, companies, and
   high-wage jobs.

#### Resilience Workshop

On May 29, in conjunction with the start of hurricane season, the BDB hosted a Resilience Workshop for local businesses at IRSC's Martin County campus. The event featured a variety of subject matter experts who detailed the importance of preparing their business for disasters and significant business interruptions. Topics included business continuity planning, applying for low and no-interest loans, and supply chain contingency planning. Speakers and panelists from a variety of organizations participated as well, including SBDC, SBA, SFMA, FloridaMakes, Martin County Emergency Management, C3 Complete technology firm, the



National Association of Home Builders, CareerSource, the Solar Energy Loan Fund, FPL, West Advisory, and the Martin County Economic Council.

#### Martin County Emergency Management Partner Meeting

O BDB staff attended the June 4 Martin County Emergency
Management Partner Meeting, which coincided with the start of
the 2025 hurricane season. The meeting, held in the Emergency
Operations Center off Monterey Road, featured partner updates
and highlights, including a preview of the 2025 hurricane season
from the National Weather Service as well as details about
meaningful resources, like the Martin County Long-Term Recovery
Group. This group, led by the Martin Interagency Network for
Disasters (MIND), unites local nonprofits, government agencies,
and community organizations to support residents in the
aftermath of a disaster.

#### Martin MPO FTAC Meeting

- The Martin MPO's Freight Transportation Advisory Committee met on June 5. The BDB has a seat on this board, represented by Executive Director William Corbin. There were several notable updates at this meeting:
  - Martin County's Transportation Improvement Plan (TIP) is scheduled to be adopted in June 2025
  - Roadway enhancements are a major part of the TIP (e.g. widening SR-710 to for lanes, from two lanes, out to Okeechobee).
  - Construction for the FEC Railroad Crossing grade separation is anticipated to start in 2029. A public open will happen sometime in Fall 2025.
  - Martin County's 2050 Long Range Transportation Plan anticipated to be adopted by the County Commission in October 2025. The next public Open House is scheduled for August 26<sup>th</sup> at 4:30 pm in the City of Stuart Commission Chambers.
  - Top concerns of the 2050 Long Range Transportation Plan
    - 1. Traffic Congestion
    - 2. Safety

#### Boys & Girls Club – New Stuart Location

I had the opportunity to tour the new Stuart club location. It will be a great resource for our local community, in terms of workforce and talent pipeline development – it has a number of working labs with instructors teaching nationally-certified courses in a select variety of CTE skilled trades, ranging from electric to culinary as well as fashion.

#### St. Lucie EDC

o BDB staff met with the St. Lucie EDC team. The goal was to start and engage in an open dialogue about economic development activities across the Treasure Coast and discuss challenges and best practices that relate to each of our organizations. Most importantly, we brainstormed about potential opportunities for partnership and collaboration with each other, on a regional level. Programming and event collaboration possibilities in the workforce development space appear to be the most promising. We will continue to communicate with each other moving forward, because strong partnerships are a priority and represent a key method whereby the BDB can maximize its impact on the local business and entrepreneur community.

#### Speaking Engagement (Jensen Beach Chamber)

- On June 19th I spoke with the members of the Jensen Beach Chamber of Commerce at their monthly lunch meeting. I delivered an overview of the BDB's vision, mission and goals, and I detailed the importance of what the BDB does – and how that directly and positively impacts tax revenues for Martin County and the individuals and families who live there.

# **Executive Summary**

This report provides an update on the Business Retention and Expansion (BRE) activities undertaken by the Business Development Board of Martin County (BDBMC). The BRE program continues to focus on strengthening relationships with existing businesses, identifying opportunities for expansion, and resolving challenges that may impact local industry.

Recent activities included conducting several Pulse Visits across Martin County and completing follow-up actions from those visits. Follow-up actions included referrals to the Stuart Martin Chamber of Commerce for membership opportunities, workforce-related referrals to CareerSource and Career Connect, referrals to the Small Business Development Center (SBDC), and a referral to Select Florida for international trade assistance. I also attended ribbon cuttings and other chamber events to further engage with the business community.

I met with representatives of the South Florida Manufacturers Association (SFMA) to discuss including SFMA in future Pulse Visits with Martin County manufacturers. Additionally, I continued working with Executive Director William Corbin on several business attraction projects.

# Purpose of Business Retention and Expansion (BRE)

#### The BRE program is designed to:

- Strengthen relationships with existing businesses and industries.
- Identify challenges and opportunities for local businesses.
- Provide resources and solutions to support business stability and growth.
- Enhance economic sustainability through strategic partnerships and community engagement.
- Foster an environment where businesses can thrive and expand within Martin County.

The purpose of this report is to update the BDBMC Board of Directors on recent BRE activities and progress.

## **Business Retention & Expansion (BRE) Update**

#### **Recent Activities:**

- Conducted several Pulse Visits.
- Completed follow-up actions from Pulse Visits.
- Pulse Visit follow-ups included referrals to the Stuart Martin Chamber of Commerce, CareerSource, Career Connect, SBDC, and Select Florida for international trade assistance.
- Attended ribbon cuttings and other Chamber events.
- Met with South Florida Manufacturers Association representatives to discuss including SFMA in future Pulse Visits.
- Worked with Executive Director William Corbin on business attraction projects.

### **CRE Forum Update**

- The CRE Forum is set for July 17 at 8:30 a.m.
- The event will be held at the Martin County Realtors of the Treasure Coast Office, in partnership with MCRTC.
- This year's event is rebranded as: Horizons – What's Next: Real Estate, The Economy, and Martin County.
- Currently, approximately 90 registered attendees.
- \$3,200 in sponsorship commitments.

## Paris Air Show Follow-up

- Sent follow-up emails to all members of Daher Aerospace's team met at the Paris Air Show.
- Conducted a meeting with local Daher officials to address issues raised in Paris.
- Currently coordinating a meeting with Daher's North American Head of the Logistics Division, to take place in Stuart.

Through direct engagement, resource facilitation, and strategic partnerships, we continue to support local businesses in their growth and retention efforts. Moving forward, the focus will be on expanding outreach, strengthening collaborations, and proactively addressing the needs of businesses to foster long-term economic sustainability in the region.
